The total value of the offer is Rs. 20.50 Lakhs exclusive of GST (Rupees Twenty Lakhs Fifty Thousands only) **(Phase – 1: Rs. 5.50Lakhs towards Tender Bid Document Preparation and Evaluation + Phase -2: Rs. 15Lakhs towards Project Management Consultancy (PMC) service).** The GST as applicable at the time of payment will be paid extra. The contract period for the PMC services will be from the date of issue of work order to the EPC contractor and upto commissioning of the entire system by the EPC contractor.

Time Frame – PMC services para ‘6’ of your proposal under ref cited ‘2’ above shall be “The total time frame for the PMC (site services) services will be 12months from the date of the work order issued to the EPC contractor and payment will be linked with mutually agreed milestone achievements and no additional contract price for duration exceeding 12months. All other terms and conditions are as mentioned in the proposal submitted by you.
